

Gateway Transformation Project Phase One Celebration

On September 27, 2017, the West Michigan community celebrated the completion of construction on the first phase of the Gerald R. Ford International Airport's Gateway Transformation Project. The first phase of the Gateway Transformation Project includes a consolidated passenger security checkpoint which centralizes and combines security screening to one main checkpoint in the airport, eliminating separate screening for passengers traveling through either Concourse A or B.



New finishes include terrazzo flooring, lighting fixtures, restrooms & nursing rooms, family restrooms, pre- and post-security kids play areas, pre- and post-security business centers, meet and greet space, and much more.

“For four straight years we have seen record passenger growth, and we are on pace to make it a fifth. We saw a need to make improvements for the passengers, and to continue to deliver top-notch customer service and amenities,” said GFIA Board Chair Roger Morgan. “We are committed to being West Michigan’s gateway to the world. We want people to step off the plane and know they’re in West Michigan.”

1,200+ Participants Put the “Run” in Runway During the 5K

The day started out cold, windy, and rainy, but that didn't dampen the spirits of the GFIA Runway 5K participants as more than 1,200 runners and walkers laced up their sneakers for this special event. The race loop began (and ended) near the cargo facilities, continuing through the tunnel under the north/south runway, looping around by the airport fire station, and wrapping around on Runway 8L/26R – GFIA's general aviation runway. The Airport's two other commercial aviation runways were operational, giving participants a chance to soak in an up-close-and-personal sight.

“This was a tremendous opportunity for runners, walkers, and families who wanted to experience a fun event on one of our runways that is normally only being used for aircraft,” said GFIA President & CEO Jim Gill. “It was exciting to see West Michigan come out and experience our facility like never before, plus support a wonderful charity at the same time.”




GFIA selected Make-A-Wish Michigan as its charity of choice to donate the race proceeds.

Engineering Change

On September 30, GFIA said farewell to Engineering & Facilities Director Tom Ecklund. Having served in this role since 2003, Tom was a key player in many construction projects during his tenure.



Throughout his 14 years, Tom oversaw more than 20 projects encompassing pavement reconstruction and expansion both airside and landside, the addition of new jet bridges at

all gates, the Terminal Area and Parking Improvement Project which included the parking garage, roadway canopy and much more, the Stormwater project, most recently, phase one of our Gateway Transformation Project, and many more.

In all, the projects completed under his watchful eye totalled roughly \$286.7 million. That’s quite a legacy to leave behind, and we are grateful to Tom for leaving GFIA a better place than when he came.

Taking the reins of leadership as our newest Engineering & Facilities Director is Casey Ries. He originally joined our staff in 2014 as our Engineering Manager. Casey brings 14 years of combined engineering and aviation experience to the position. He is a Licensed Professional Engineer, Certified Industrial Storm Water Operator and FAA Licensed Private Pilot. He is also the Coordinator of the Capital Area MATHCOUNTS program, and the President of the Grand Ledge Robotics Club.



In his former position, Casey played a critical role in phase one of the Gateway Transformation Project; he will continue by overseeing the design and construction activities of phase two, which are scheduled to begin in late 2018.

New retail space includes “A Touch of Grand Rapids” store, a partnership with Hudson News, and new food & beverage space includes a Starbucks post-security, and Prospect Hill Brewhouse, a collaboration with HMSHost.


“HMSHost is thrilled to be a part of Gerald R. Ford International Airport’s Gateway Transformation Project. With the recent openings of Prospect Hill and Starbucks, HMSHost has brought both local and national favorites to Grand Rapids travelers,” said HMSHost Vice President of Business Development Bryan Loden. “We’re honored to continue our partnership with the airport, and our partner Steve Jenkins of Diversified Installations, to elevate the traveler experience with even more great food and drink options to kick off their journey.”



Of the \$45 million project, over \$17 million was raised through sponsorships, with the remainder of the support coming from airport funds and passenger facility charges. Sponsorships included an \$8 million donation from Amway as the title sponsor of the Gateway Transformation Project. eSpring drinking fountains and other Amway branding can be seen throughout the airport space.

Other sponsorships of \$1 million and up include Meijer, SpartanNash, Spectrum Health, Steelcase, and Wolverine Worldwide. SpartanNash has partnered with the airport to add a Military Welcome Center (see page 4). Spectrum Health Helen DeVos Children’s Hospital has redesigned and added new Kids Play Areas, family restrooms and nursing rooms for new mothers; and Steelcase has outfitted four business lounges pre-and-post security with its collection of office furniture.

The airport has also worked with the Gerald R. Ford Presidential Foundation to incorporate an exhibit dedicated to the 38th President, which is located pre-security in the Grand Hall (see page 4).



A reconstructed indoor observation area on the mezzanine of the Grand Hall where passengers may see friends and loved ones depart for their flight is also a part of the newly designed space.


Construction spanned 21 months, is estimated to have utilized 223,200 man hours, and expanded the Airport building by over 59,000 square feet.

A second phase, which will include improvements to the airline ticketing, baggage screening, and baggage claim areas, is currently in the design phase. Construction is slated to begin in 2018.

Airport Dedicates Ford Tribute Room

As part of the Gateway Transformation Project, the Gerald R. Ford International Airport worked with the Gerald R. Ford Presidential Foundation to incorporate a permanent exhibit space dedicated to the 38th President. The exhibit space, located pre-security, includes photos, an aircraft carrier model, displays, and rotating historical pieces.

At the ribbon-cutting ceremony for the Tribute Room, President Ford's son, Steve Ford, said, "Dad would be extremely proud to know that the foundation and the airport that bear his



name came together to honor him with this tribute room. He loved growing up in Grand Rapids, and it is humbling to know that he will always have a place to be remembered. This tribute room at the Gerald R. Ford International Airport is a terrific place for generations that knew my father to spend time reflecting on the past, but also for future generations to learn about what he meant to our country and to West Michigan."

The Tribute Room is open to visitors and airport patrons 24 hours a day.

New Military Welcome Center

The Gerald R. Ford International Airport (GFIA) welcomes thousands of military members and veterans each year, and now there is a special place at the airport for them to call their own. GFIA and SpartanNash have partnered to present the Military Welcome Center, a private space located pre-security near the Concourse A exit.

"At SpartanNash, we are deeply committed to serving our military heroes and their families, both at home and abroad," said Dave Staples, SpartanNash President and Chief Executive Officer. "We are honored to present the Military Welcome Center, because it allows us to be a part of the journey of those who served and continue to serve."

The Military Welcome Center is open to military members, veterans, and their families 24 hours a day. The center offers snacks, refreshments, magazines, and lounging spaces. There are also interactive maps and murals where military personnel and veterans can pin where they have been stationed or deployed.

Airport Employee Information Corner

Safe wintertime air travel operations depend upon aircraft and airfield pavement deicing activities, which are strictly regulated by the Federal Aviation Administration (FAA). The GFIA Deicing Management Program controls and manages spent deicing materials at the airport through the use of best management practices, recycling, and other mechanisms designed to help protect the environment. GFIA's program requires organization, teamwork, and implementation of specific structural controls, practices, and procedures to manage deicing materials.

To facilitate the recycling of deicing chemicals, GFIA restricts airport users to employ only propylene glycol-based aircraft deicing products. GFIA has also banned the use of nitrogen-based deicing products (e.g., urea) and tenants are reminded that materials containing urea are not allowed for use anywhere at the airport.

Through constant refinement to its Deicing Management Program, the cooperation of airport tenants, and the hard work of its employees, GFIA strives to help ensure the safety of the traveling public while also taking necessary steps to protect the local environment. GFIA also reminds everyone that the active participation of staff and tenants is a critical part of the overall stormwater management program at the airport. If you observe any practices or situations that appear to have the potential to impact the quality of stormwater at the airport, call Airport Communications at 233-6055 and report your observation(s).
