

## **GFIA Named Top Airport in North America**

The Gerald R. Ford International Airport provides first-class travel experiences and excellent customer service and amenities, and those efforts have been recognized by Airports Council International (ACI) as the best in North America.

ACI has announced the Gerald R. Ford International Airport has achieved the first place ranking in the "Best Airports by Size and Region – North America (2-5 million passengers per year) category, and tied for second place ranking in the "Best Airport by Region – North America (all airports over two million passengers per year) category as a part of ACI's 2015 Airport Service Quality (ASQ) Awards.

"Customer service is a top priority for our entire team at the Gerald R. Ford International Airport and we are thrilled to be recognized as the top performer of our size in North America," said GFIA Executive Director Brian Ryks. "We're dedicated to ensuring continued progress in this area as we make significant investments in personnel, services, and facilities focused on providing a first-class experience from the vehicle curb to the aircraft gate. We are working to improve the passenger experience every day, and this award reflects that effort."



"We are thankful for all of the tenants and stakeholders who are the front-line service providers behind this award," said Ryks. ## Southwest Airlines Now Offering Nonstop Service to the Windy City

Southwest now offers nonstop service to six cities from GFIA, adding Midway to a list of flights that includes Baltimore/Washington, Orlando, Denver; and seasonal service to Tampa & Fort Myers. The new flights from Grand Rapids to Midway began on April 12 and



operate three times daily.

## **Airport Director Departing**

The Gerald R. Ford International Airport (GFIA) Board has announced that Executive Director Brian Ryks has been hired as CEO & Executive Director at the Minneapolis-Saint Paul International Airport.

Ryks, who has led the executive staff at GFIA since July 2012, was selected as the finalist for the Twin Cities position by the executive committee of the Metropolitan Airports Commission (MAC) in Minneapolis in early March. The full commission voted, and unanimously endorsed the recommendation on March 21.

"While we are saddened to lose such a tremendous leader who has done nothing short of exceptional work in his time at the Ford Airport, we are excited for Brian both personally and professionally as this is a huge step up in his career, and a chance to go home to family," said GFIA Board Chairman Roger Morgan. "Brian spearheaded several large projects, and put us on the map of air service development and customer service. He has led the airport during a period of record growth – including a nine percent surge in passenger counts in 2015, the arrival of Southwest to the market in 2013, and extensive facility improvements over the past couple of years; all of which paved the way to launch our Gateway Transformation Project in December."

Morgan said that the board will move quickly to find a replacement. "The search process will include the board, as well as representatives from our business community," said Morgan. The Airport has largely completed its transition from a department of Kent County government to regional airport authority governance. Final approval on that transition is expected from the Federal Aviation Administration on July 1, 2016.

Take a tour through many fire stations and you will likely find a station table; a table that is personalized to represent the firehouse and firefighters who work there; a place to gather as a team for work, meals, or recreation. After five months, FF Smith went to a lumber yard and picked up some old oak wood on his off day. The next day he brought the wood to the station and a plan began to come together.

An addition to the station table was then proposed by firefighter Bryan Wolcott. He had a fire hose donated, and it was used to create an American flag. FF Smith and FF Wolcott designed and framed the flag.

Gerald R. Ford International airport won the Mitigation award for its sustainable stormwater/deicing runoff control project. The airport's project involved an extensive planning and design process with significant and sustained engagement from both airport and community stakeholders to come up with solutions to address glycol-impacted



stormwater runoff from the airport.

"Each year, our member airports continue to impress in their ability to innovate and implement better and more sustainable strategies to protect and preserve the environment," said ACI-NA President and CEO Kevin M. Burke. "The recipients of the 2016 ACI-NA Environmental Achievement Awards are true leaders in the field of environmental management, and I congratulate them on their success."
