Starting April 4, West Michigan travelers have another new option for air travel as American Airlines began nonstop service to Ronald Reagan Washington National Airport (DCA). In addition to doing business or vacationing in our nation's capital, you can also catch a flight to any of 70 other U.S. destinations through DCA. The service, which is operated by American Eagle, features 13 weekly round trips.

"Nonstop service to Reagan National Airport has been a target market of ours, and we are happy to see American Airlines continue to invest in the Grand Rapids market," said Gerald R. Ford International Airport President & CEO Jim Gill. "American has grown 74% at the Ford Airport since 2015, nearly tripling its seat capacity - that says a lot about American's desire to expand here, and our community's response to supporting new routes."

American Airlines has served Gerald R. Ford International Airport passengers for over 25 years, and also offers nonstop service to Chicago-O'Hare, Dallas Fort Worth, Charlotte, and Philadelphia. Rounding our service line-up United, Southwest, Delta, and Allegiant Air provide nonstop flights to Atlanta, Baltimore, Chicago-Midway, Denver, Detroit, Ft. Lauderdale, Ft. Myers, Houston, Las Vegas, Minneapolis, New York-LaGuardia, New York-Newark, Orlando, Phoenix-Mesa, Punta Gorda, St. Pete/Clearwater, Tampa, and Washington Dulles.

# Busy, Busy, Busy

It has been a season of unprecedented growth for the Gerald R. Ford International Airport. After closing out 2016 4.06% ahead of 2015 and breaking another passenger record, some may have expected a slower start to the new year. They would have been wrong.

Each of the first three months of the year have broken records—January by 5.86%, February by 9.59% and March by 11.17%—so it is no surprise that we also set a new record for the busiest first quarter ever, serving 685,278 passengers. That is nearly three times more passengers than we served in the entire first full year of service at this location!

Will this growth continue? No one can say what the future holds. However, the addition of service to Reagan National (DCA) in April is one factor that bodes well by adding capacity to the market.

What we can say is, thank you West Michigan fliers for including GFIA in your travel plans!

# Stormwater Project Continues to Receive Recognition for Excellence

Each year the American Council of Engineering Companies of Michigan (ACEC/M) honors outstanding engineering and surveying projects. The Engineering and Surveying Excellence Awards Program recognizes outstanding efforts of professional design firms to meet their clients needs through exceptional projects.

This year the Gerald R. Ford International Airport's Drainage Improvement & Natural Treatment System project received the 2017 ACEC Merit Award. This \$20 million project treats stormwater deicing fluid runoff at the airport using detention, natural bacterial treatment, filtration, and natural aeration to transform nutrient-laden stormwater into clean water before discharging it into the



Thornapple River. The system is completely self-sustaining. It utilizes gravity and engineered siphons to feed stormwater into and through the natural treatment beds. The only energy used in the system is provided by solar panels that power stormwater testing equipment.

This project is a once in a lifetime project. It included many unique components not typical of airport projects. The project included coordination and/or permitting with many federal, state, and local agencies. There were many challenges in the environmental approval, design, and construction of the project. The project is the only of its kind in the State of Michigan, and one of only a few in North America. The system is performing as designed, meeting the limits prescribed by the Michigan Department of Environmental Quality (MDEQ).

[Editors Note: Shortly before going to press, we were notified that the project has earned a National Recognition Award from the American Council of Engineering Companies (ACEC) 2017 Engineering Excellence Awards (EEA) competition. The National Recognition Award is a prestigious distinction honoring projects that demonstrate exceptional achievement in engineering.]

He also met mechanics, nurses, doctors, pilots, and dispatchers who all make up AeroMed's team. ### **Employee Information Corner**

Rain and snow can create stormwater runoff when they fall on pavement and other impervious surfaces. Pollutants can be picked up and carried with this stormwater, possibly creating adverse effects in streams, rivers, and lakes. In fact in some places, these 'non-point' sources of pollution can be significant contributors to the impairment of our waterways.

GFIA's stormwater is conveyed to local surface waters by the airport's storm sewer network. While much of the airport's stormwater is now routed through the new Natural Treatment System, the airport and its tenants are still required to employ good housekeeping practices for all outdoor activities to minimize and prevent the potential for stormwater to come into contact with polluting materials. Good housekeeping practices include making sure dumpster lids are closed. This simple practice minimizes the potential for rain and snow to accumulate and come into contact with potential pollutants. Other practices used as part of GFIA's stormwater management program are described in the airport's Stormwater Pollution Prevention Plan, which is available on the airport website (FlyFord.org/environment-zoning.php).

The continued participation of GFIA staff and tenants is important to our stormwater management program. If you observe practices or situations that may have the potential to negatively affect the quality of stormwater at the airport, call Airport Communications at 233-6055 to report your observation(s). These situations could include the improper disposal of wastes, improper discharges to the storm sewer system, or any other activity that appears to have the potential to introduce pollutants into the storm sewer system.
