The event was held inside the brand new Bell's Brew Pub, a West Michigan favorite. The celebration also included the opening of HMSHost's restaurant, Greens, which features healthy, fresh dishes, and the refurbishing of the existing Starbucks.

Airport Board's Arrivals and Departures

Policy and general oversight of GFIA are the responsibility of the Gerald R. Ford International Airport Board, a seven-member body appointed by the Kent County Board of Commissioners. The Airport Board comprises three Kent County commissioners, three Kent County citizen members, and one citizen member from a county other than Kent in the West Michigan combined statistical area, each serving staggered three-year terms.

At its December 2013 meeting, the Board said farewell to citizen member Terri Lynn Land. Chairman Roger Morgan stated, "We are grateful to Terri for her service and wish her the best of luck in her upcoming campaign."

On January 9, the Kent County Board of Commissioners appointed Steve Heacock, senior vice president of public affairs at Spectrum Health, to a three-year term on the Airport Board. A former County Commissioner, Steve has served on many are boards, including the Greater Grand Rapids Chamber of Commerce, Grand Action, and the Michigan Make-A-Wish Foundation.

News In Brief

- » The next three meetings of the Gerald R. Ford International Airport Board will be held on February 26, March 26, and April 30. Meetings begin at 8:30 am and are held in the International Room in the passenger terminal building. Meetings are open to the public.
- » Public Safety & Ops Director Rob Benstein has been appointed to the National Safe Skies Alliance Oversight Committee which provides policy guidance and sets priorities for the Program for Applied Research in Airport Security.
- » Fire Chief Todd Szakacs has been appointed to the Western Michigan Association of Fire Chiefs Board.

Airport Employee Information Corner

Safe wintertime air travel operations depend upon aircraft and airfield pavement deicing activities, which are strictly regulated by the Federal Aviation Administration (FAA). GFIA and its tenants control and manage deicing materials through the use of best management practices (BMPs), recycling, and other mechanisms designed to help protect the environment. GFIA's program requires organization, teamwork, and implementation of specific structural controls, practices, and procedures to manage deicing materials.

GFIA has started construction activities associated with the Long-Term Stormwater/ Deicing Runoff Management Program including a natural treatment system (NTS) to promote the on-site biodegradation of deicers. Day-to-day deicer removal rates will vary with weather conditions and deicer usage rates, but the NTS is expected to remove about 80% of the deicers from GFIA's stormwater on an annual basis. This will provide environmental protection that exceeds state and federal requirements.

Tenants are reminded that use of nitrogen-based products (e.g. urea) are not allowed anywhere at the airport. If you need information on approved deicing products may contact Roy Hawkins, planning engineer, at (616) 233-6000 or via email at RHawkins@grr.org.

GFIA also reminds everyone that active participation by staff and tenants is a critical part of the overall stormwater management program. If you observe any situations that appear to have potential impact on the quality of stormwater at the Airport, call Airport Communications at 233-6055 and report your observation.
