Mr. King-Dye, asset owner, recommends continuing the Concourse B renovation architectural/design services with HKS, and a team of consultants, to maintain the consistency of services provided on the Concourse A Expansion and Widening project. He is asking approval of a contract with HKS not to exceed \$973,345.00 for design services to renovate Concourse B, and authorization for the President & CEO to sign all associated documents.
