11-3 **Resolution 23-21:** New SRE Building – Construction Phase Contracts

Mr. Berghage said the current configuration of the Field Maintenance facility was constructed in 2000. As part of the Airfield Maintenance master plan, a new Snow Removal Equipment (SRE) building will be constructed adjacent to the existing Field Maintenance building and the new SRE building will protect approximately \$15 million of equipment that is currently stored outside or in other remote buildings from exposure to the elements. Consolidating the SRE into one building allows Field Maintenance staff to deploy equipment quicker during snow events. The Authority is asking for the approval of project contracting authority not to exceed \$8,500,000.00 for the construction phase of a new SRE facility, and authorization for the President & CEO to sign all associated documents.

11-4 **Resolution 23-22:** Economy Lot Expansion – Drainage Area Construction

Mr. Weiler said near and long-term expansion of the Economy Lot to support parking demand is currently constrained by an open airport drainage ditch. Drainage improvements, including ditch enclosure, is necessary for future phases of expansion of the Economy Lot. The Authority is seeking approval of project contracting authority not to exceed \$1,345,000.00 for the construction of Economy Lot Expansion drainage improvements, and authorization for the President & CEO to sign all associated documents.
