at which time the bids will be publicly opened and read aloud.

2. PRE-BID MEETING

Ford International Airport Authority are subject to Airport Rules and Regulations and the health and safety protocols in place at the time of the site visit.

A bidders information meeting will be held at the Economy Parking Lot Exit Plaza, 5500 44th Street SE, Grand Rapids, MI 49512 on Thursday, September 9, 2021 at 1:00 pm. Attendance at the bidders information meeting is **optional** for all General Contractors wishing to submit a bid on the project. Minutes of the bidders information meeting will be forwarded to all plan holders as an addendum.

3. SCOPE OF PROJECT

The project consists of furnishing all material and constructing the following:

46,150 Sq. yards of HMA Surface removal
8,550 tons of HMA pavement construction
80,000 Sq. feet of pavement markings
Replacement of existing parking lot lighting fixtures
Installation of an emergency generator for the existing Exit Plaza
Furnish and install two (2) 20' x 20' waiting shelters
Furnish and install emergency and customer communications system

Including all necessary appurtenances and restoration.

5. DEPOSIT FOR DRAWINGS AND SPECIFICATIONS

Bidder assumes sole risk for any project specifications and drawings, electronic or hard copy, obtained other than directly from Prein&Newhof. Hard copy drawings and specifications are available for the fee of \$170.00 dollars. Prein&Newhof Plan Room members who want to purchase the hard copy of the drawings only, may do so for \$90.00 dollars. A \$15 dollar charge will be added to all mailed drawings and/or specifications. Fees are payable by cash or check only and are not refunded.

6. FUNDING

The work to be performed under this contract will be financed and paid for by funds received from local sources.

7. BID SURETY

A bid bond, certified check, or cashier's check payable to Gerald R. Ford International Airport in an amount equal to five percent (5%) of the total price shall accompany each bid. This surety shall bind the bidder for a period of Sixty (60) days after the receipt of bids.

8. COMPLETION DATE

All work except for the emergency generator, lighting fixtures, waiting shelters and other long lead time items shall be completed by October 31, 2021. Stop and start orders will be issued if necessary for delivery and installation of long lead time materials and equipment. An additional ten (10) working days to complete installation of long lead time items.
