#### 1. Welcome, Introductions and Sign-In

AJ Nye (GFIAA) introduced the project and gave a brief overview of GRR and the project. All meeting participants introduced themselves. Complete list of meeting participants and contact information is provided on the attached Sign-In sheet.

#### 2. GFIAA Contract Requirements and Proposal Forms

GFIAA provided an overview of the contract requirements and explained key dates and times of the bidding schedule for this project..

- **3. Project Description** Alex DeHaan (RS&H) provided a brief description of the project noting all major work items.
  - Asphalt pavement removal, curb & gutter removal, fence removal
  - MDOT 801 Concrete Entrance Drive
  - MDOT 802 Concrete Curb & Gutter
  - Contractor to remove existing pavement markings; GFIAA to self-perform permanent pavement markings
- **4. Phasing** Mr. DeHaan present the Phasing plan provided in the project plans and explained the anticipated items of work to be completed in each phase.
  - Phase 1 Demolition, Concrete Entrance Drive, Curb & Gutter, Restoration
  - Phase 2 Pavement Markings Mr. DeHaan explained that the marking phase of the project is meant for GFIAA but, MOT devices may need to remain in place while GFIAA installs the proposed pavement markings.
  - Total Contract Time = 12 calendar days

#### 5. Site Access and MOT Plan

- No security badging required
- Construction Staging and Parking area
- Maintenance of Traffic Plan (G041) Mr. DeHaan shared the MOT plan in the project plans. All MOT items listed below will be paid for under Item 812-1 "Project Safety and Maintenance of Traffic".
  - Signs & drums
  - o Includes construction flagger
  - Maintain access to nearby bus shelter
  - Contractor may use lane closure for loading/unloading Mr. DeHaan emphasized that all soils excavated are to remain on the project site and be incorporated as embankment against the proposed curb lines.
  - Bus Shelter is located plan East of the MOT plan which shall remain operational during construction.

#### 6. Technical Specifications & Special Provisions

- MDOT 801/802 Concrete Curb & Gutter / Driveways
- MDOT 812 Maintenance of Traffic



- SP-01 Contractor Quality Control Mr. DeHaan explained the roles and responsibilities of each QC/QA party noting that this is explained in Special Provision SP-01 of the Project Manual.
  - o QC Subgrade, Agg Base, Concrete
  - QA Concrete The Owner's materials testing representative will be on site for materials testing during concrete placement. QC testing and delivery of these reports to the engineer will be required for the materials listed in SP-01.
- SP-02 Reimbursed Utility Modifications Item SP-02 "Reimbursed Utility Modifications" has been included as a contingency allowance in the contract documents for situations where the contractor must relocate or otherwise modify existing buried utilities within the project limits. This includes both private and public utilities. The Contractor will be required to submit a cost proposal for the modification of such utilities before utility work is to begin. This item may go unused/unpaid should utilities not impact construction of the project.
